Offer of US-Dollar Fixed Rate Certificates of Deposit

The Bank of Jamaica announces the issue of a one year FR US-Dollar Indexed Note as follows:

Maturity Date:	14 February 2017
Tenor:	365-days
Settlement Currency:	Payable in JMD using a rate of US\$1:00=J\$120.9034 which is the BOJ 10-day moving average buying exchange rate applicable on Friday, 12 February 2016 .
Coupon:	1.95 percent per annum
Interest Payment Frequency:	Quarterly
Rate of Exchange for Payment of Principal and Interest:	For each quarterly interest payment and at maturity, the applicable exchange rate will be the BOJ 10-day moving average selling exchange rate applicable on the date of payment multiplied by a factor 1.002 .
Prepayment Option:	The Bank of Jamaica reserves the right to effect prepayment operations on this instrument. The terms and conditions for all prepayment operations applicable to this instrument will be provided in the Term Sheet.

However, the Bank reserves the right to close this instrument before 12:30 p.m. on Thursday, 18 February 2016.

The Term Sheets will be circulated via electronic mail to all Primary Dealers and commercial banks and will also be available on the Bank's website at www.boj.org.jm.
