April 2008

For April 2008 there was a current account deficit of **US\$161.7 million**, which represented a deterioration of **US\$83.5 million** relative to the corresponding period of 2007.

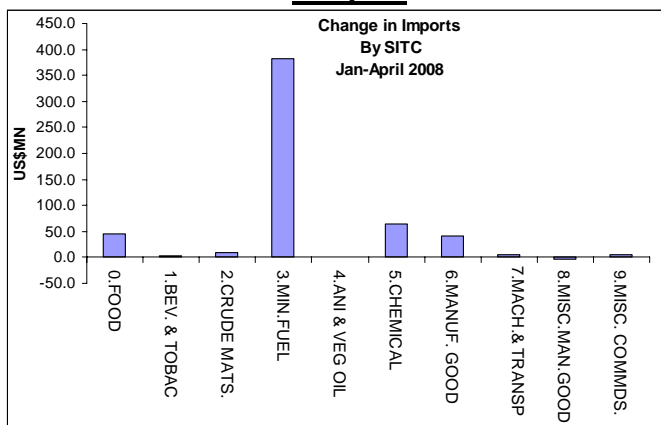
The deterioration resulted primarily from the performance of the goods, services and to a lesser extent the income sub-accounts as current transfers recorded improvements (Table 1). During the month the goods balance recorded a deficit of **US\$316.0 million**, a deterioration of **US\$83.4 million**. This resulted from an increase in imports of **US\$147.1 million** which was significantly influenced by an increase in *Mineral Fuel* imports of **US\$71.0 million**. Significant increases were also observed in the categories **Machinery & Transportation** and **Food** of **US\$24.5 million** and **US\$22.6 million** respectively.

Flows from official and private sources were more than sufficient to finance the current account deficit, consequently the NIR increased by **US\$79.5 million** during the month.

January –April 2008

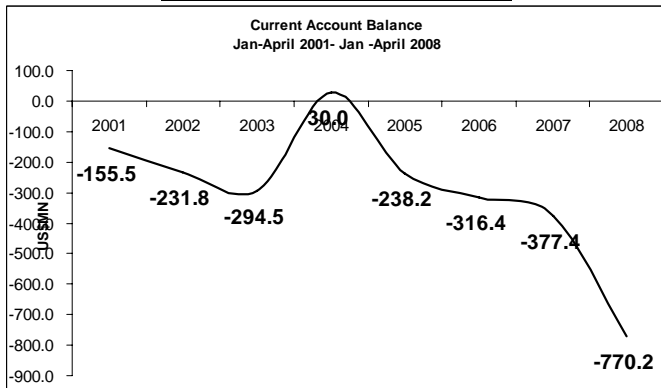
For the first four months of the calendar year 2008, there was a current account deficit of **US\$770.2 million**, which represented a deterioration of **US\$392.8 million**. This resulted from deteriorations in all sub-accounts except current transfers (Table 2).

For the goods sub-account, there was a deficit of **US\$1368.3 million**, which represented a deterioration of **US\$406.0 million** relative to the corresponding period of the previous year. This performance resulted from an increase of **US\$510.1 million** in imports which were partially offset by an increase in exports of **US\$104.2 million**. The increase in imports was driven primarily by *Mineral Fuel*, *Chemicals* and *Food* of **US\$382.6 million**, **US\$64.5 million** and **US\$46.2 million** respectively (Graph 1).

In relation to the services balance, there was a decline in its surplus **US\$22.7 million** which primarily resulted from an increased freight cost, associated with increased imports. The increase in net income outflow during the period emanated from increased interest payments by the government.

During the review period, current transfers increased by **US\$59.7 million** to **US\$671.6 million**. The improved performance resulted primarily from a **US\$76.2 million (12.7 per cent)** increase in remittances.

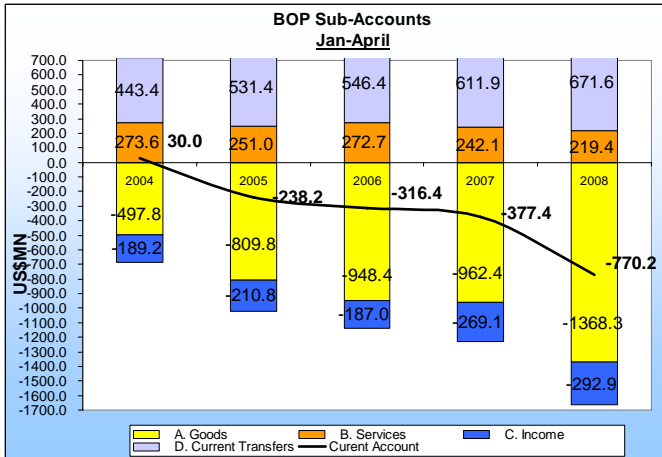
Graph 2

Flows from official and private sources were more than sufficient to finance the current account deficit, consequently the NIR increased by **US\$285.2 million** during the review period.

In relation to the historical performance of the BOP, the current account deficit of **US\$770.2 million** for January –April 2008 is the largest on record for the country for that period (Graph 2). From graph 3, it can be see that the deterioration in the current account in recent history results primarily from the performance of the goods sub-account.

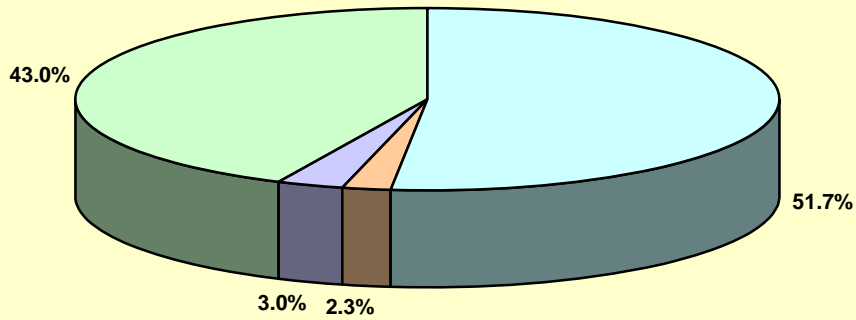
**Estimated Tourist Expenditure

Jamaica: Total Visitors

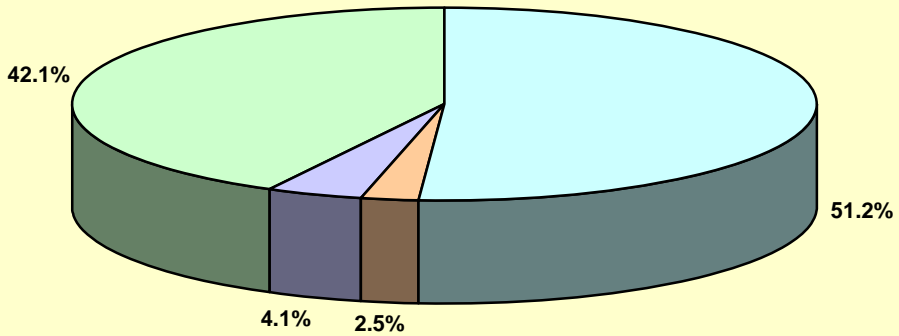


**Composition of Visitors

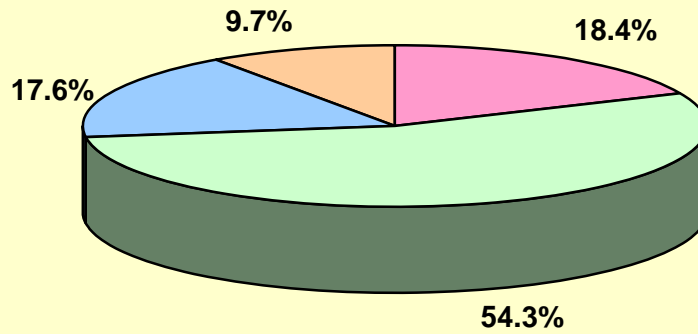

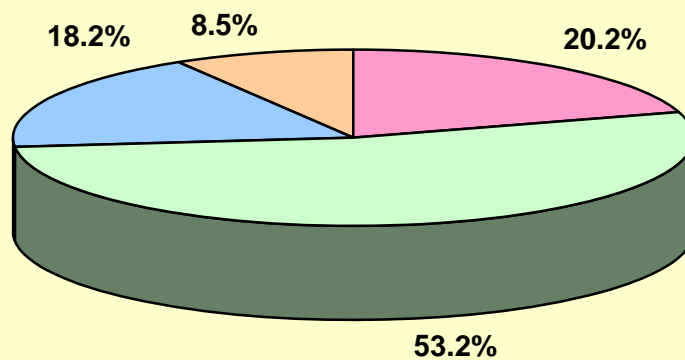
