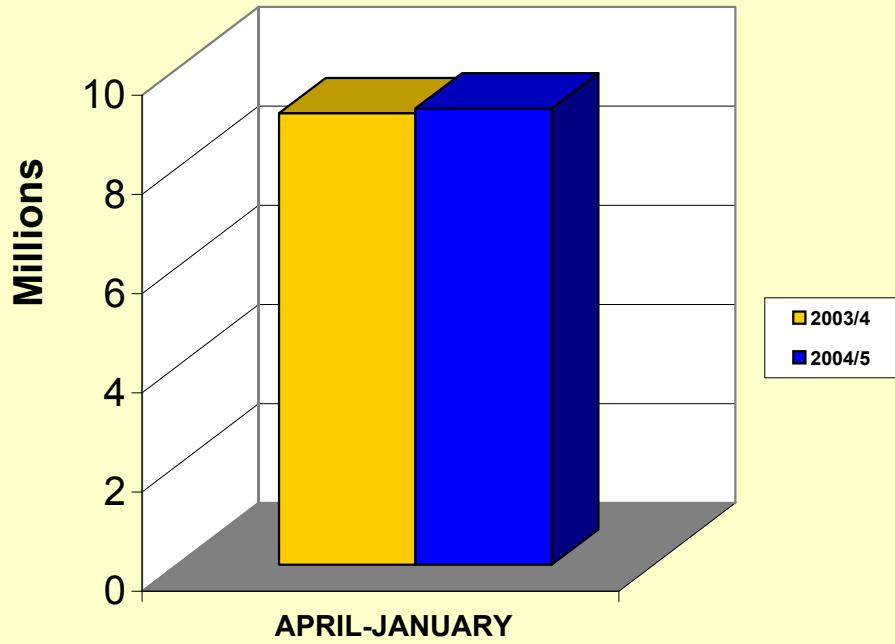

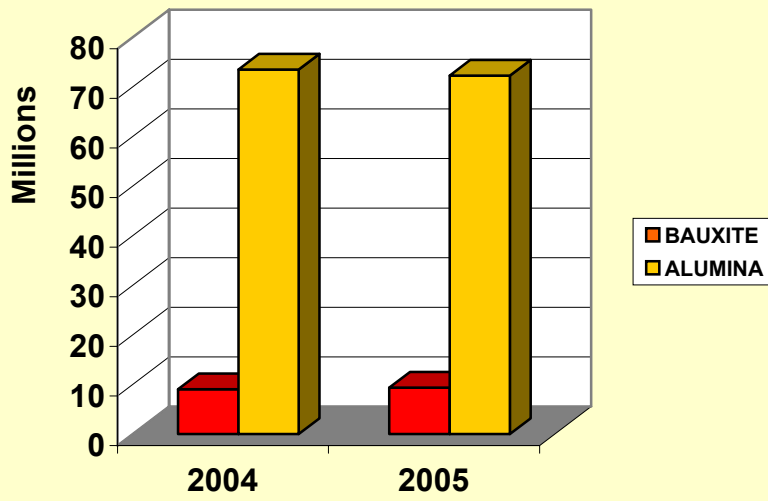

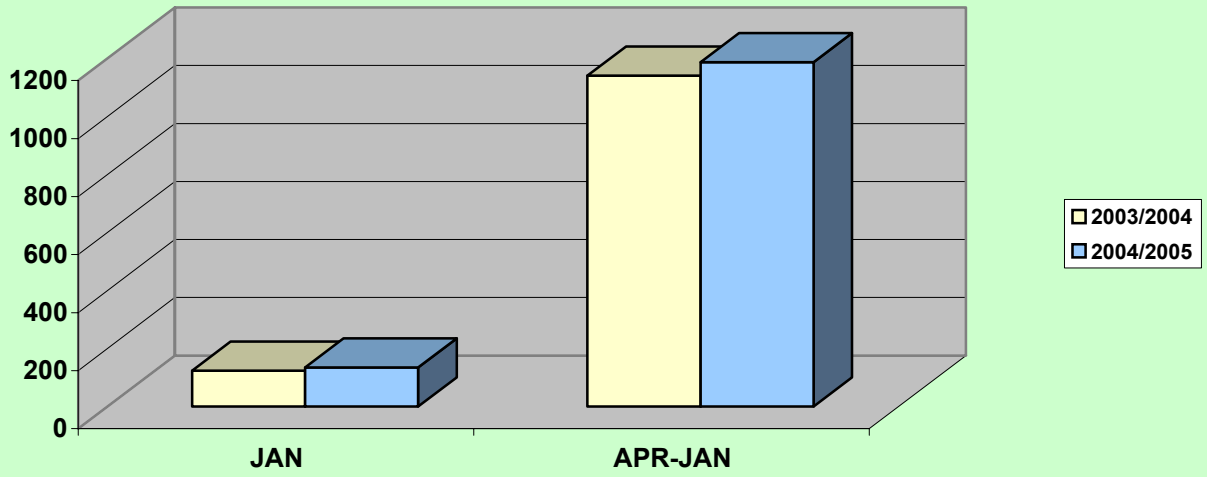

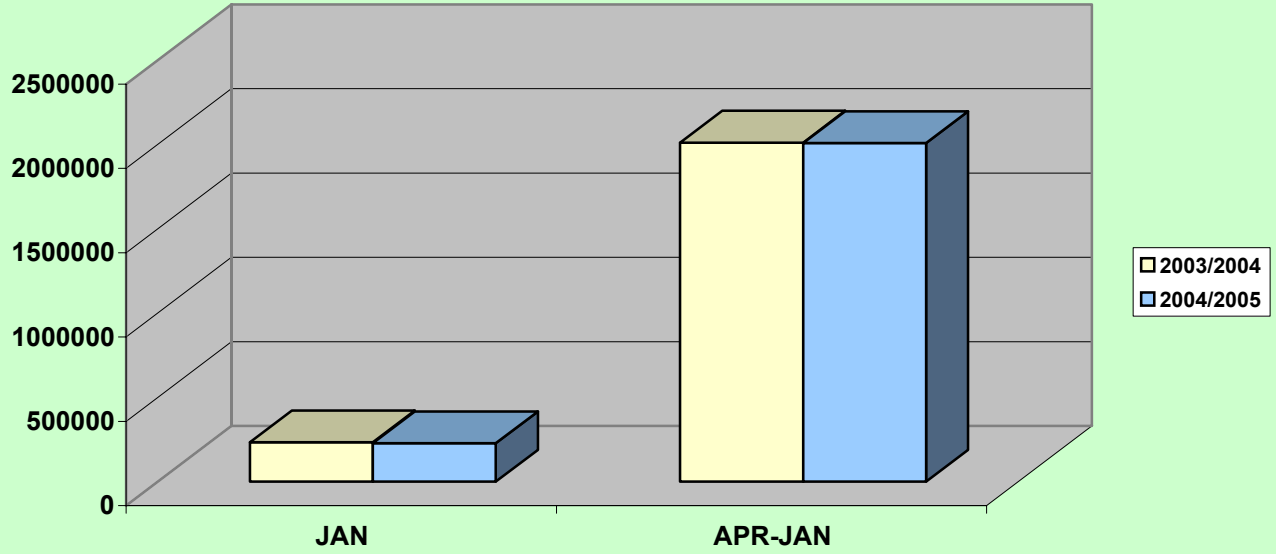

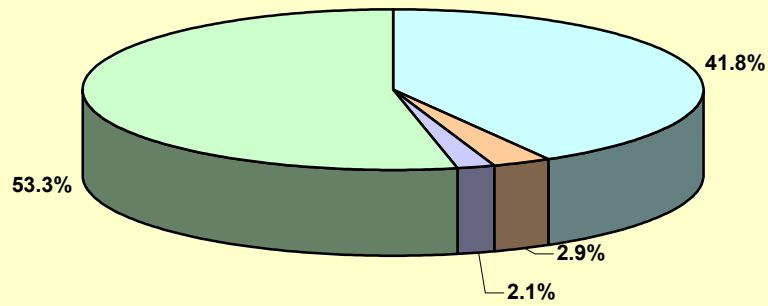
Estimated Tourist Expenditure (US\$mn)



Jamaica: Total Visitors

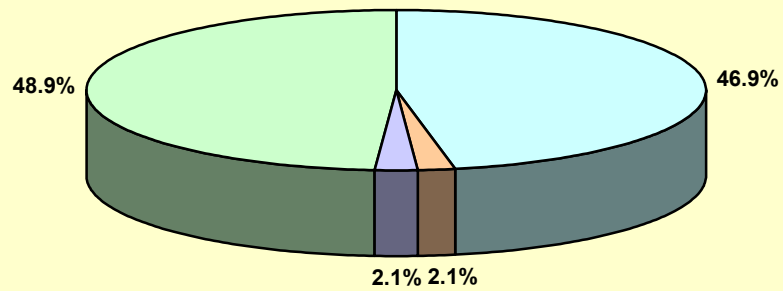


Composition of Visitors January 2004

Composition of Visitors January 2005

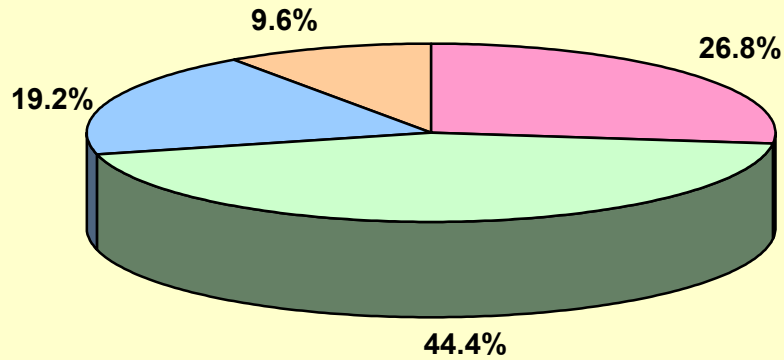

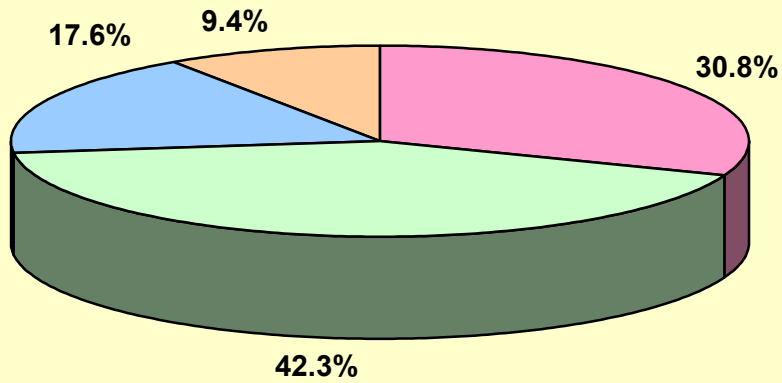
