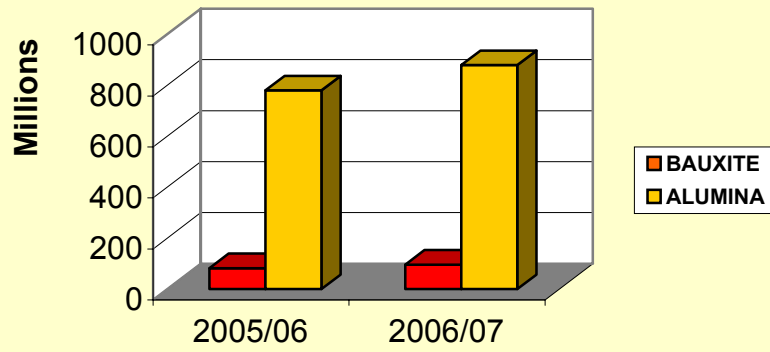

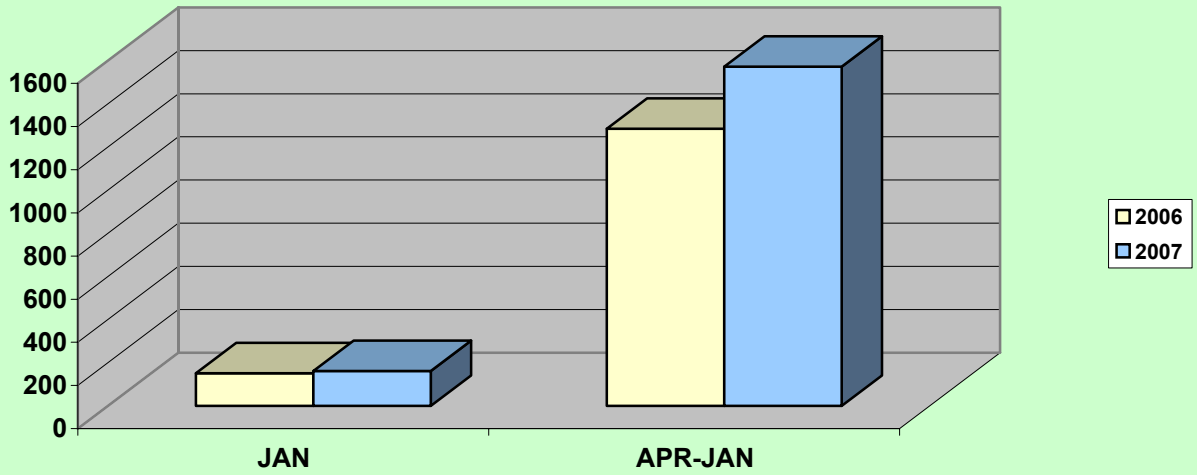

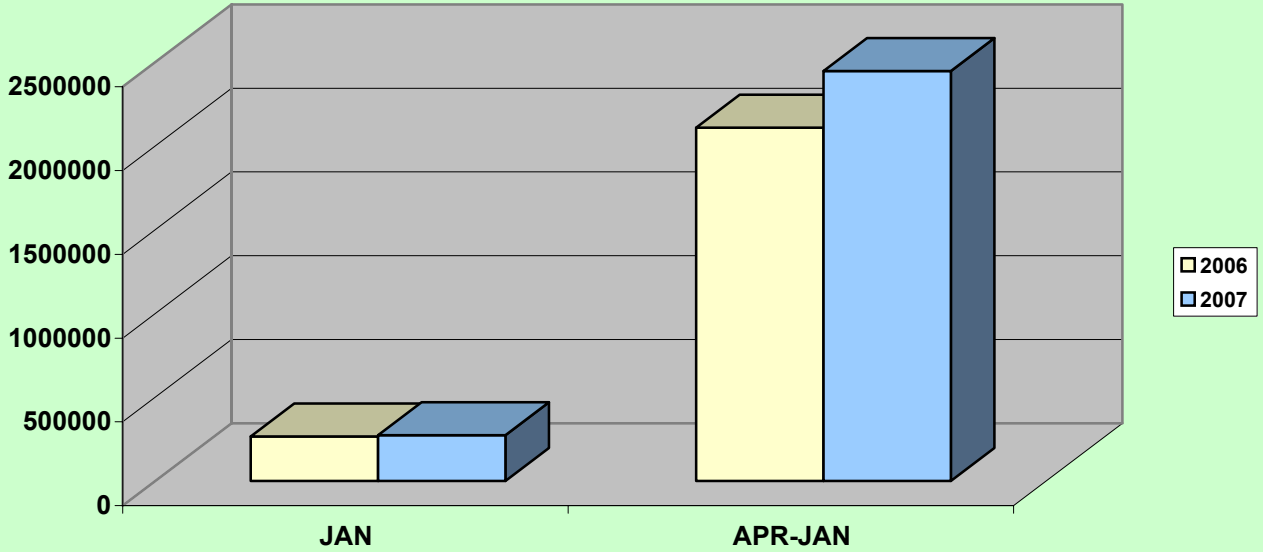

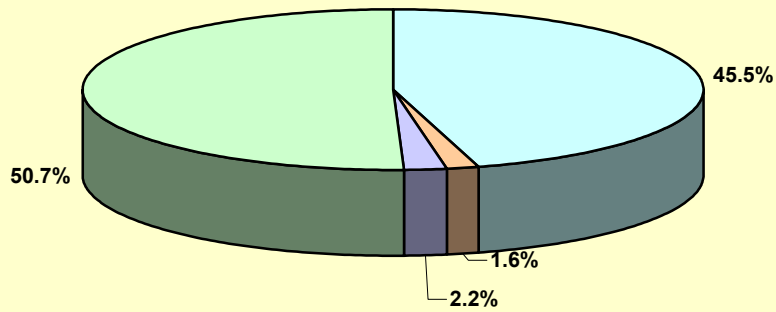
Estimated Tourist Expenditure (US\$m)



Jamaica: Total Visitors

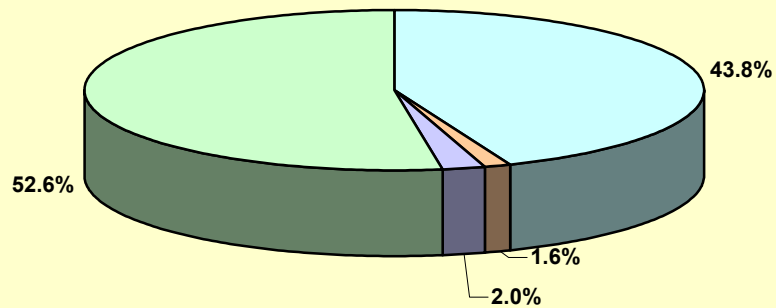


Composition of Visitors January 2006

Composition of Visitors January 2007

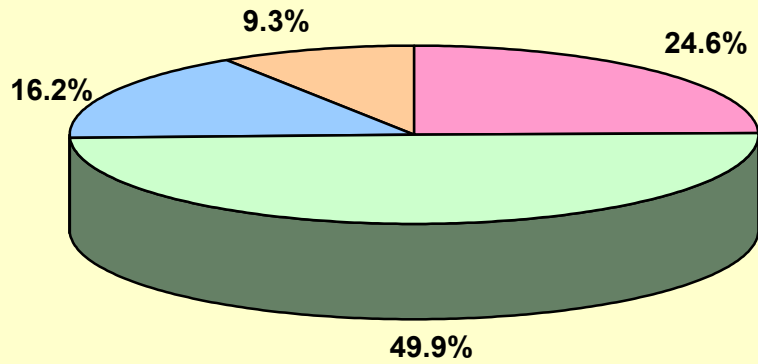

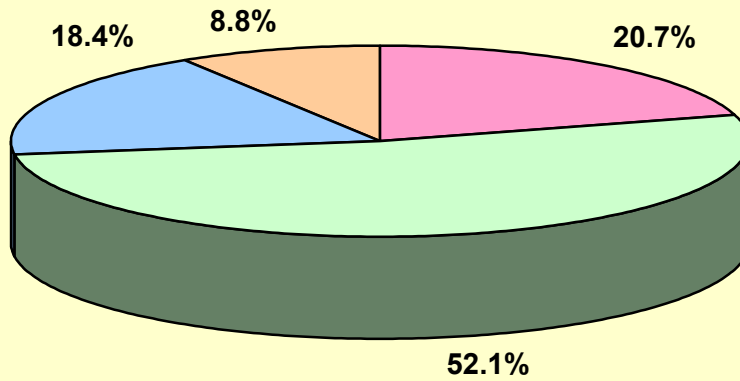
