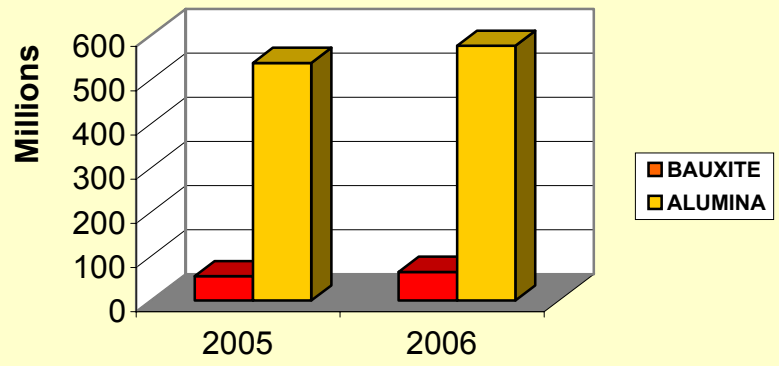

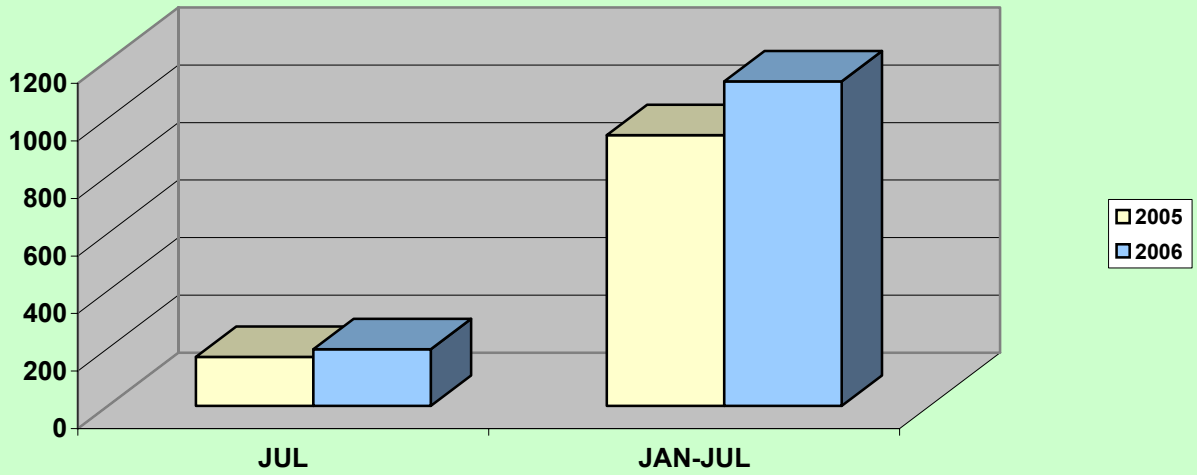

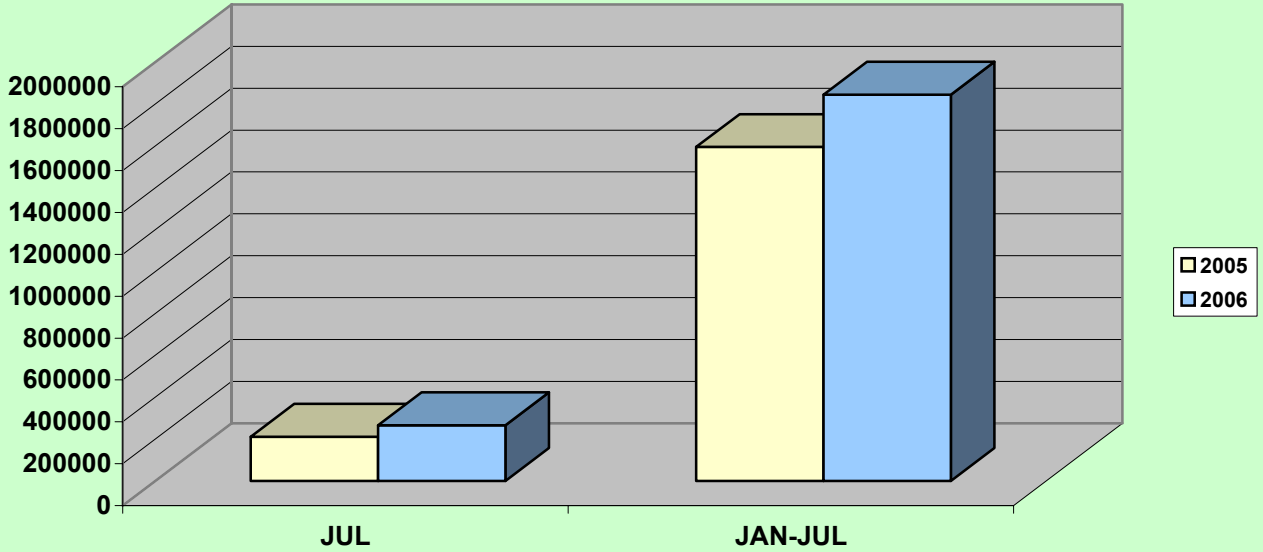

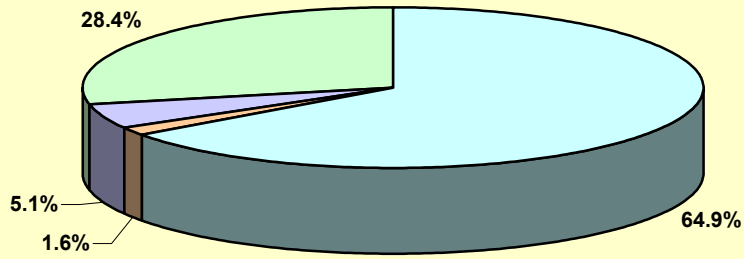
Estimated Tourist Expenditure (US\$m)



Jamaica: Total Visitors

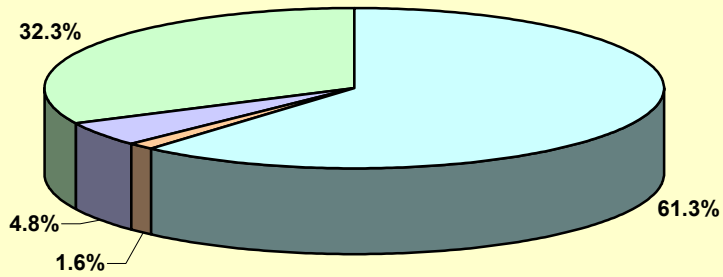


Composition of Visitors July 2005

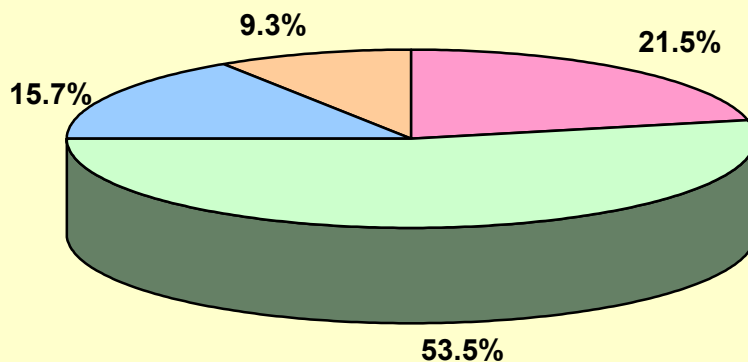

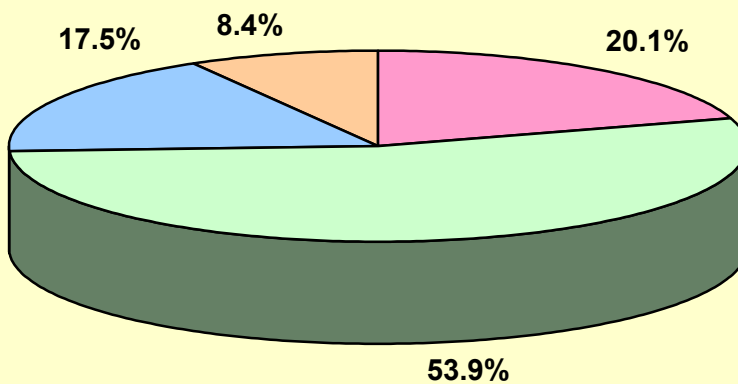
