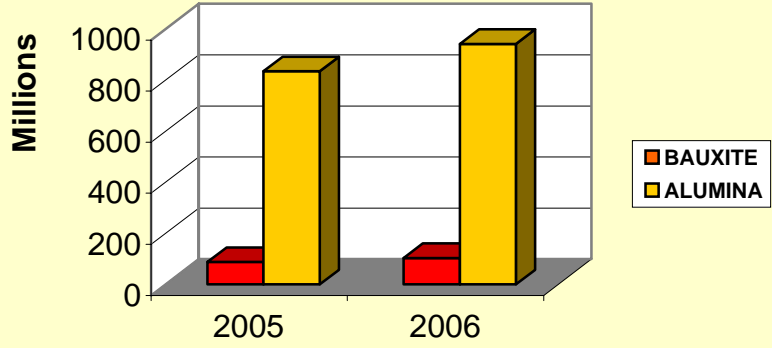

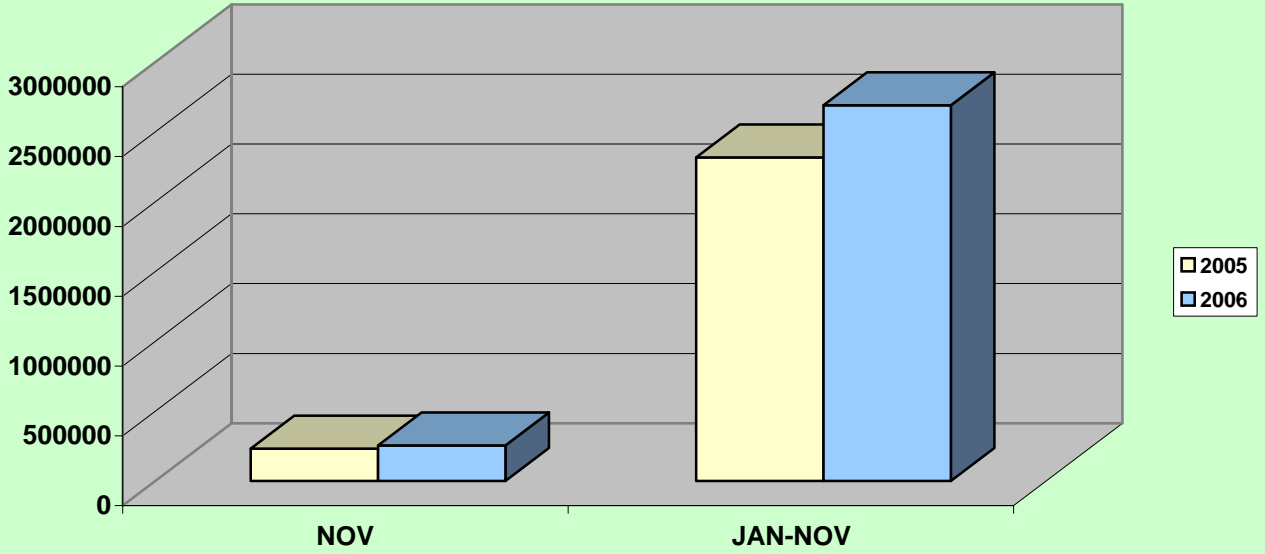

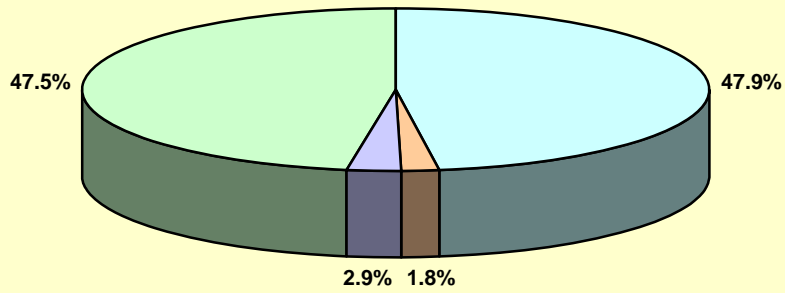
Estimated Tourist Expenditure (US\$m)



Jamaica: Total Visitors

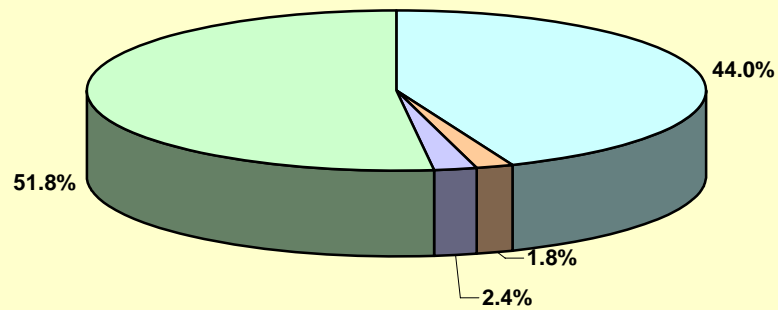


Composition of Visitors November 2005

Composition of Visitors November 2006



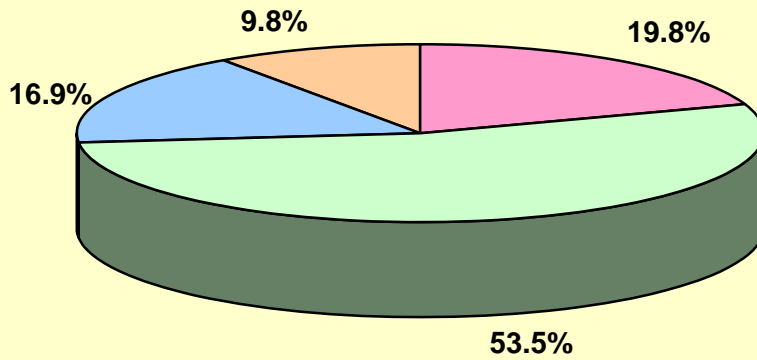

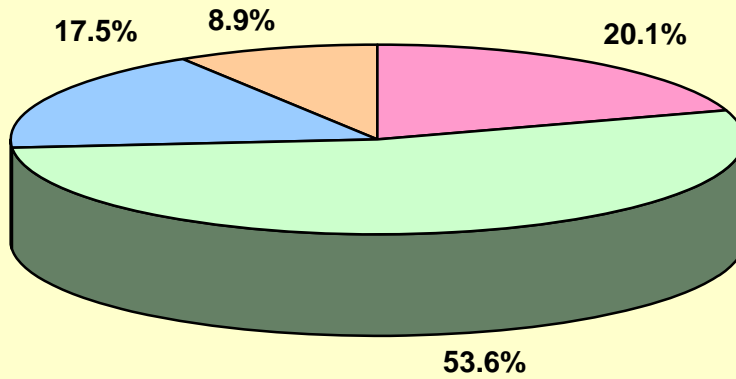
